SPRINGFIELD COUNTRY CLUB MEMBERSHIP CLASSIFICATIONS

Senior Family:

Shall include golfing, pool, tennis and social privileges to a man or woman and his/her spouse living in the same household, over forty years of age. Each shall be entitled to vote at all Club meetings. There shall be no restrictions on tee times for the Primary Member or spouse however, restricted tee times shall apply to children being under twenty-one years of age and living in the same household or any child under twenty-four years of age and a full-time undergraduate student living in the member's household. They will have the privilege of using the Club's facilities mentioned above pursuant to the rules and codes of dress, conduct and Junior Golfing Program as outlined in this book.

Senior Individual:

Shall include golfing, pool, tennis and social privileges to a man or woman over forty years of age. There shall be no restrictions on tee times. The member shall be entitled to vote at all Club meetings.

Senior Individual w/ M-3 Option:

Shall include Senior Individual privileges to the Primary Member and will also include pool, tennis and social privileges to his/her spouse and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full time undergraduate student living in the member's household. There are no golfing privileges for the Social member. The Social member is not entitled to vote at Club meetings.

Intermediate Family:

Shall include golfing, pool, tennis and social privileges to a man or woman and his/her spouse living in the same household, ranging from ages 21-39. Each shall be entitled to vote at all Club meetings. There shall be no restrictions on tee times for the Primary Member or spouse however, restricted tee times shall apply to children being under twenty-one years of age and living in the same household will have the privilege of using the Club's facilities, mentioned previously, pursuant to the rules and codes of dress, conduct and Junior Golfing Program outlined in this book.

Intermediate Individual:

Shall include golfing, pool, tennis and social privileges to a man or woman ranging from ages 21-39. There shall be no restrictions on tee times. The member shall be entitled to vote at all Club meetings.

Intermediate Individual w/M3 Option:

Shall include Intermediate Individual privileges to the Primary Member ranging from ages 21-39 and will also include pool, tennis and social privileges to his/her spouse and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full time undergraduate student living in the member's household. There are no golfing privileges to the Social member. The Social member is not entitled to vote at Club meetings.

Social Membership M-1:

Shall include social privileges to a man or woman and his/her spouse and their children, which children being under twenty-one years of age and living in the same household or any child under twenty-four years of age and a fulltime undergraduate student living in the Member's household. No Member in this category is entitled to vote at Club meetings.

Social Membership M-2:

Shall include pool, tennis and social privileges to a man or woman and his/her spouse and their children which, children being under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household. Limited golfing privileges of one round a month per spouse are allowed during restricted tee times (Monday-Friday) excluding holidays or tournament play. Payment of cart fees is mandatory. No member in this category is entitled to vote at Club meetings.

Non-resident Membership:

Shall include golfing, pool, tennis and social privileges to a man or woman and his/her spouse and children which, children are under twenty-one years of age and living in the member's household or under twenty-four years of age and a full-time undergraduate student living in the member's household provided that the member and his/her family are domiciled year round more than 50 miles from the Springfield Country Club. Tee times are unrestricted for all family members over twenty-four years of age but must be arranged through the Club Professional at least twenty-four hours prior to play. Non-resident Members may play no more than twelve rounds of golf per year and shall pay all appropriate greens fees and cart fees. Each round by a guest or family member will be included in the twelve round limit. There shall be no voting rights in this classification.

Clergy:

Shall include golfing, pool, tennis and social privileges to a member of the clergy. Tee times are unrestricted. The member is entitled to vote per membership at all Club meetings.
